Hello Colin, I wanted to first tell you not to worry about apologizing for the delay. I understand the trials and tribulations of everyday life on the outside and how time seems to stand still in here. While my situation still remains as depressing as the day I found out what happened at my home and my subsequent wrongful arrest and incarnation; I wanted to thank you again for reaching out to me and continuing to speak with me. I also wanted to take this moment to be thankful that all my "bunkies" and cell mates have been kind and friendly despite everyone's circumstances... Including my own. With regards to my bond status, I am still looking to try and procur the funds or post it by collateral but it seems to be rather difficult when you don't have contacts on the outside. It seems to be my half-brother's mission to make my life that much harder by not believing me, communicating with me, or helping me; even after I was blessed with a very high bond. The decision to provide me with a bond was decided because of a reason that is outside of my legal knowledge (improper procedures at the very least). I can't speak for the judge's personal discretion but I believe my judge is very fair and understanding at the very least. I feel blessed to have her as my judge. I will say this before getting into the rest of the message; hearing about anime and Japan and my home in Chuluota brought tears to my eyes, because they all remind me of the family that was taken from me and the brother I loved more than anything in this world... I won't bring up my love for Silvie in this message because that's all the media seems to obsess about. My relationship with her has nothing to do with anything that has happened. Anyways, you mentioned Anime. I love it and miss it. It was a passion my brother Cody and I shared and started at the same time. I have to give him full credit for exposing me to anime all the way back in 2013. At the beginning, we would watch previously aired shows together. He would download the series and we would watch them together. The first 5 anime we watched together were "Full Metal Panic," "Gundam 00," "Full Metal Alchemist," "Code Geass," and "Deathnote." Code Geass is still, to this day, our favorite anime of all

time. And this is after 6 years, 1,000s of shows, and 1,000s of hours logged in this "hobby." As I stated, my brother Cody and I would watch almost every new series that came out each season (4 seasons per year and roughly 30 series per season; each ranging from 13-26 episodes) and we watched countless series and movies that were previously released. Cody had such a knowledge and passion for anime that I fell in love with it with him. I remember numerous nights that we would would finish an episode or a series and talk the night away over coffee down in the kitchen. Thinking of this brings several other anime to mind that I would recommend; so I will name a couple and a few production companies and artists...there are just too many to name but if you wish to know more, I'd enjoy talking about this for hours. I would recommend anything by Kyoto Animation, SHAFT, Clamp, or Sunrise. Some specific shows besides the ones I mentioned above would be K-On (my 2nd favorite anime of all time; I've watched the series over and over about 7 times o o), Nichijou, FMA Brotherhood, 10 Centimeters Per Second (makes me cry everytime), Hunter x Hunter, Gundam SEED/SEED Destiny, God's Memo Pad, and just soooooo many more. I love anime so much. :'(I have been to Japan. I actually just went with Cody from December 1, 2018 - December 15, 2018. I cry as I write this because it was one of my last wonderful memories with Cody. Because of our love for the culture that was derived from all the anime we watched, it was a dream of ours to go to Japan and experience this wonderful culture. I don't think that your statements were naive, I thought the same things...I even distinctly remember turning to Cody as we were walking through Tokyo, Kyoto, Shinjuku, etc and saying, "there is not a single piece of trash on the sidewalk." Plus, did you notice that no ones eats while walking? And that there are no trash cans besides at the vending machines or "7-and-I?" Lol We went to so many places while we were there and stayed in so many beautiful ryokans that it was truly a dream come true. We even made a deal to make it an annual thing. While we were by no means fluent in the language we adopted the honor and respect of the society while we were there. I remember when we arrived back in the States that I was still bowing and saying "Excuse me and I'm sorry" in Japanese. (Embarrassing, I know). This is another topic that I could go on and on about and if you'd like, I can talk about this more as well. Regarding Chuluota, its another topic all on it's own. It was my home for 25 out of my 29 years of being alive. It used to be so recluse and rural but over the past 5 years has had a great deal of development. This is both a good and bad thing. Fortunately, we lived in an old neighborhood that stayed peaceful despite all the development. Our property was about 4-acres and it started with hundreds of beautiful pine and oak trees and palmetos. It was almost like a forest. Then hurricane Charlie came around and tore down so many trees. Fortunately, that home never sustained any damage after all the years and hurricanes. The people there weren't what I would call "eccentric" but "elitest." They are a proud community that doesn't want to change and be a part of all the development. All the development brought many stores and commodities to our rural world. My only complaint about living right where I did was that the extremely fast internet packages hadn't reached us yet...neither did Uber eats...sad, I know - - There is so much more to all these stories and I'd love to talk about them all with you. Maybe even without my privacy being invaded by this place. I have your number now and would like to call you. If I

can bond out of here this coming week, I would like to talk with you this way. If you happen to know any millionairs who would like to post my bond, I'd be eternally grateful and I'd give exclusive rights to you for my story. Sadly, I know that this is not a fairytale world but I figured I'd still throw that out there just in case you do. Thank you again for everything and I look forward to our next conversation and the depth they will keep going into. I have nothing to hide in this world. I loved my family more than anything and Silvie was a beautiful and new addition to that love. I miss everyone and everything and not being able to talk with everyone in my life has been so hard.
